### **Description**

There is a requirement to tender for the provision of Cleaning Services at Buckinghamshire Council Corporate Offices and cross county sites, to ensure we are keeping our buildings clean and safe to fulfil our health and safety obligations. There are 74 sites in total.

The contract will be for an initial term of 3 years, commencing on 1st of August 2026 and ending on 31st July 2029. The contract may be extended by one further 2-year period, and then another further 1-year period, making a potential total contract length of 6 years. The total contract spend for the full 6 years is estimated at £ 9,252,939. This is only an estimate, and the actual spend maybe higher or lower than this figure.

This service is being procured using a two-stage procurement process which consists of:

- Stage 1 Invitation to Participate – A selection process using a Procurement Specific Questionnaire (PSQ)
- Stage 2 Suppliers successfully shortlisted at Stage 1 of the Procurement will be invited to submit tenders.
