The Authority is responsible under the Immigration Act 1971 and the Immigration and Asylum Act 1999, for the detaining and/or enforcing the removal of certain persons (Detainees), being persons detained under the Acts and assigned by the Authority to an Immigration Removal Centre (IRC) from the United Kingdom (UK).

At any one time, approximately 3,400 Detainees are held overnight in one of seven IRCs, two residential Short-Term Holding Facilities, Pre-Departure Accommodation (PDA), prisons and police stations across the UK.
