Funding from the National Lottery Heritage Fund, Welsh Government and Cyngor Gwynedd's Lewyrch o'r Llechi project via UK Levelling Up Funding now offers a real opportunity to re-imagine and re-define the museum within a range of contextual settings – from the hyper-local to the global through the newly achieved UNESCO World Heritage status
