The Staffordshire Police, Fire and Crime Commissioner seeks to commission a Staffordshire and Stoke-on-Trent Restorative Justice Service. The Restorative Justice Service will support the delivery of the Victim Code of Practice, provide a free, confidential, high quality service, raising awareness of and guiding and supporting victims who wish to explore a range of restorative interventions. The aim of the market engagement day will be to examine the proposed specification and answer any questions in relation to the requirement and procurement process, before the formal tender is launched. Interested parties will be asked to provide details about their organisation and to indicate if they wish to book a 1-2-1 session with Commissioners.
