- Locked Hybrid mattresses cot mattress.
- A bed maintenance and repair service (Trust owned/lease equipment).
- A mattress/ bed decontamination would be required if swapping out/replacing.
- A bed and mattress tracking service.
- A range of specialist pressure relieving mattresses and beds for patients whose requirements fall beyond the coverage of the new standard pressure relieving mattress.
- An annual planned preventative maintenance programme
- Annual mattress audits.
- On-site/Off-site technician service for individual Hospitals.
- Off-site storage facility

- Controlled usage against established protocols.
