The framework will be awarded to one or more Contractors to a maximum of 4, per skip size, based on their ranking, or less if there are not 4 suitable Contractors to undertake the Contract.

Work will be awarded to the top ranked Contractor. If that Contractor cannot provide the required skip the next ranked Contractor will be used.

Delivery of the skips will mainly be at locations throughout Gateshead but may extend to other parts of the region. This will be specified at the time of order.
