Similar services have been available since 2006.

Additionally, the Council is also seeking a Critical Incident stress/trauma Response Service on an 'as needed basis' which has also been in place since 2006, although to

date this has not been utilised.

Durham County Council are looking for a single specialist provider who can deliver this service.
