BACKGROUND

All Age Carers Service:

The aim of this service is to provide a comprehensive offer of support - including groups, activities, guidance and interventions - to those who have caring responsibilities for someone in Blackburn with Darwen. This will be available to carers of all ages, including young carers (5-15 years); young adult carer (16-18 years), and adult carers (18+ years).

Information and Advice Service:

The aim of this service is to support residents to identify services, groups, and support offers that enable them to maintain their independence. It will support the Council's strengths-based approach and form a core element of the local prevention offer, supporting individuals to build on their own capabilities and reducing on reliance on statutory services.
