The geographic scope of the DPS is UK-wide. Its focus is to target the build of gigabitcapable broadband infrastructure in the final 20% (f20) of the country that is not commercially viable for the market to design, build and operate without government intervention. Following successful admission of Suppliers onto the DPS, Suppliers can tender for Call-Off Contracts. Each Call-Off Contract will vary in terms of number of premises covered, value and geographic coverage. BDUK currently expects the average Call-Off Contract size to be around 1,000 to 8,000 premises.

The DPS will be used by BDUK and will be available to the UK's Devolved Administrations to award Call-Off Contracts. Devolved Administrations refers to the National Assembly for Wales; the Scottish Government; and the Northern Ireland Assembly and Executive Committee.
