The focus of the Regional Supplier Contracts is to target the build of gigabit-capable broadband infrastructure in the final 20% (f20) of the country that is not commercially viable for the market to design, build and operate without government intervention.

This procurement is for the award of Regional Supplier Contract – Dorset & South Somerset (Lot 14.02). This covers the geographic area of Dorset & South Somerset.

The Contract concerns the delivery of a gigabit-capable network for an estimated total number of 22,604 premises compromising 7,577 in the initial scope and 15,027 in the deferred scope. BDUK intends to make available £43,150,000 of public funding available for this contract.
