The Contracting Authority is leading on the procurement process to establish a Framework Agreement for the Supply of Forklift Trucks (herein after referred to as "Goods") and is seeking suitably qualified Contractor(s) to supply the Goods and any related Services under any Agreement resulting from this tendering exercise. The estimated total value of the Framework Agreement is stated in II.1.5) of this notice and is for the four year term. For the avoidance of doubt, the estimated annual value of the Contract will be approximately £20,000 - £1,000,000. Please note that this is a Framework Agreement and this range allows for other Authorities to join the Framework, however there is no guarantee of any spend. The Framework Agreement will be awarded for an initial term of four years, with no extensions. Please note that the contract requirements will be subject to available financial resources, supplier performance and flexibility to meet changing demands. There will be no form of exclusivity or volume that is guaranteed under the resultant Framework Agreement and the Council and other participating authorities will be entitled to enter into other contracts and arrangements with other suppliers for the provision of any, or all, of the requirements which are the same as, or similar to those specified under the established Framework Agreement. Organisations should be aware that due to the nature of the Services provided, any Framework Agreement formed as a result of this procurement process shall be executed as a deed. Organisations should seek independent legal advice on the implications of this prior to submitting their bid, where appropriate.

This period allows unsuccessful tenderers to challenge the decision to award a Framework Agreement before a contract is executed/signed (as appropriate). The Public Contracts Regulations 2015 ('Regulations') provide for aggrieved parties who have been harmed or at risk of harm by a breach of the rules to take action in the High Court (England, Wales and Northern Ireland). Any such action must be brought promptly and within the time limits as defined in the above regulations. Where a Framework Agreement has not been entered into the court may order the setting aside of the award decision or order the contracting authority to amend any document and may award damages. If the Framework Agreement has been entered into the court has the options to award damages and/or to shorten or order the Framework Agreement ineffective.
