KCC are expecting to commission the One You Kent Service in two Lots. It is anticipated that tenderers will be able to apply for either or both Lots.

Lot 1: Stop Smoking Service (Kent wide)

The Stop Smoking Service will be delivered by a single provider across the whole of Kent. Countywide delivery includes the following Kent local authority areas: Ashford, Canterbury, Dartford, Dover, Gravesham, Folkestone & Hythe, Maidstone, Sevenoaks, Swale, Thanet, Tonbridge and Malling, Tunbridge Wells.
