As a result of the Covid-19 Global Pandemic and delays to COP26 due to Covid-19, the Authority's requirements demand continued access to these services beyond the current end date of the contract. The Authority is unable to change contractor at this stage for economic and technical reasons, and to do so would cause significant inconvenience and substantial duplication of costs for the Authority. Recognising the need for a long-term solution, the Authority is already undertaking the re-procurement activities including the internal steps ahead of ITT publication anticipated March/April 2023 of the next phase of the UK PACT programme to provide a sustainable basis for meeting these requirements. In the short term however, the Authority considers it necessary to exercise a contract amendment to Lot 2: Green Recovery Challenge Fund, delivered by ICF Consulting Services Limited. This procedure will;
