- ? The construction of extensions or large-scale adaptations to domestic properties to provide ground floor accessible living facilities for disabled people
- ? The provision of Boiler and Central Heating Installations.
- ? The provision of repairs to domestic properties as identified by the application of the Housing Act 2004 Housing Health & Safety Rating surveys
- ? Specialist decluttering and deep cleaning of properties occupied by vulnerable residents who may be displaying hoarding behaviours

This contract will be divided into lots:

- LOT 2 The installation of boiler and central heating installations
