YPO are looking for providers to develop an internal contract for freight forwarding services, mainly concerning sea freight, with possibility of utilising air freight occasionally when required. Currently YPO are shipping between 100-130 20 and 40ft containers into the UK annually from global ports including Yantian and Ningbo to Southampton and Felixstowe. The stock is then delivered into YPO's warehouse in Wakefield.

YPO are keen to engage with suppliers in the market to support the development of our internal contract for freight forwarding services and ensure that the contract is fit for purpose.

In particular, YPO would like to receive feedback from suppliers in respect of the following elements:
