Plymouth City Council (PCC) is committed to working with partners to transform the way we deliver Early Help and Targeted Support for families with children aged 0-19, over the next ten years.

We want to commission a Partner or Partners to work with us to develop and drive a 10 year Early Help (Family Hubs) Programme. This approach was approved by PCC's Cabinet in March 2021 and it aligns with Plymouth's new Bright Future vision for children and young people 2021-2026, due to be considered at PCC Cabinet on 13th July.
