The Authority seeks to invite companies to tender for the removal of the waste using their own skips and equipment to reduce the number of trips from the depot to the disposal site. Any skips supplied would need to be adapted to cater for the safe tipping of waste from small compact mechanical sweepers and fitted with a drainage system to allow excess water to drain away from the waste.
