This may be for reasons (including but not limited to) that the awarding of this Contract as two separate Lots/Options provides significantly better value to the Council in terms of the overall annual service cost compared to Lot/Option 1. However, even where this is the case, bidders are reminded that our preference is to award Lot 1/Option 1, and the Council's decision will be final.
