NHS Hampshire and Isle of Wight Integrated Care Board are seeking a provider who will provide safe and effective secure transport for individuals with mental health needs (under various sections of the Mental Health Act 1983), and a support and observation (sitting) staff service for patients during detention or stay in a Place of Safety or acute hospital emergency department (ED) under this legal framework - namely Section 136 of the Mental Health Act.
