HEIW reserves the right to pause, halt, abandon and/or annul the tendering process and not to award any or all the Contracts. The Contracts to which this procurement relates are funded via Welsh Government funding, refer to the contract terms and conditions and the ITT for rights reserved to the contracting authority should the said funding cease or reduce. Bidders are to

(a) The number of student places to be commissioned annually will be conditional upon Welsh Government confirmation of funding; and

(b) HEIW reserves the right to vary the range of student commissioning numbers by way of an increase or decrease; and

(c) The proposed contract is due to take effect on or around 01/01/2024 and provide for an implementation period. Delivery of the services are to commence upon the anticipated Services Commencement Date (that is on or around 01/08/2024). No contract payments are payable in respect of the implementation period.
