Translink/NITHC are looking to explore options for the supply, Install and maintenance of Electric Vehicle (EV) Charging Stations within each of these sites. There is also a possibility of other sites being included during the initial contract period.

The purpose of the Pre-Market Engagement process is to obtain information that provides the most efficient way of installing and managing EV charging points.
