Dorset Council is undertaking early market engagement with the aim of providing information to and requesting feedback from highway suppliers, about aspects of the Council's Highway Term Service Contract. The next Highway Term Service Contract is due to commence on 1st April 2027.

Organisations who may be interested in this opportunity are invited to complete and return the Pre Market Engagement questionnaire document by 12:00 noon on 6th May 2025.

This Preliminary Market Engagement Notice is not a call for competition. It is being published to give notice to the market of an upcoming procurement anticipated for release in March 2026.

Dorset Council is undertaking early market engagement, with the aim of providing

information to and requesting feedback from highway suppliers, about aspects of the Council's Highway Term Service Contract.

The market engagement exercise is intended to allow interested suitable organisations with appropriate experience to outline their views and ideas about the future provision of these services.

The operational service delivery elements would commence on 1st April 2027.

No information provided in response to this questionnaire will be used by the Council in assessing providers during the procurement process, which is scheduled to commence March 2026.

Any procurement for the supply and services required by the Council will be carried out strictly in accordance with Procurement Regulations.

Potential bidders are all encouraged to register on the Central Digital Platform.

The anticipated value of the proposed new Highways Term Services Contract is £200m over a proposed 10-year period commencing April 2027. Dorset Council is looking for a

suitably sized Tier One contractor with extensive experience of large construction and highway projects who can deliver a range of highway maintenance and infrastructure projects.

The Council wishes to seek feedback from the industry in the following specific areas, but would welcome any additional comments also:

- Contract processes
- Incentivisation
- Co-location
- Reciprocal trade
- Social Value
- Flexibility & Responsiveness

The process will involve relevant companies and organisations responding to the market engagement questions provided on the Council's e-tendering portal
