- Type A - Fully Enclosed
- Type B - Cantilever with End Advertising Panel x2
- Type C - Cantilever
- Type D - Cantilever with Narrow Roof
- Type E - Cantilever with Ends
- Type F - Cantilever with Front/Rear Advertising Panel x2

Durham County Council anticipates replacing and renewing approximately 20-30 bus shelters per annum through this Framework Agreement.

The Council intends to invite the 5 highest scoring bidders to tender, subject to having passed Part 1, Part 2, and the other sections of Part 3, and achieved a minimum weighted score of 65% for the Technical Questions.

Following this tender exercise, a maximum number of three bidders who achieve the highest weighted tender scores will be awarded a position on the Framework.
