## II.2.4) Description of the procurement

The improvement works at Queens Gardens will contribute towards delivering the objectives of HCC's City Plan. The works represent a significant opportunity for the city, as the gardens are a valuable asset of large open space within the city centre. Providing good design and better integration into adjacent areas there is potential for Queens Gardens to create a magnificent public space and an improved area to host major events.

Understanding the historic importance of the development of the gardens has been central to the design process, making sure that any improvements are carried out in a sensitive and respectful way.
