An assessment of the provider was undertaken based on the evidence available from the existing contract held by NHS Devon. Key Criteria for Quality and Innovation, Value, Integration, Collaboration and Service Sustainability and Improving Access, reducing health inequalities and facilitating choice were assessed as pass/fail with a scoring of 0-5 (with no single score of 0, and no more than 1 criteria with a score of 2 or below). Social Value was assessed with the same scoring but with a weighting of 100%.
