The Navy Command Above Water Battlespace team, part of the UK Ministry of Defence intends to enter into a contract with LiveLink Technology LTD for the provision of Counter Uncrewed Air Systems to address the need to identify Uncrewed Air System threats. The duration of the contract will be 24 months and has an estimated value of £1M. In accordance with the provisions of The Public Procurement (Amendment etc.) (EU Exit) Regulations 2020 SI No. 2020/1319, this procurement falls to be regulated under the provisions of the Public Contracts Regulations 2015 as amended (in particular by SI 2020/1319). As no suitable tenders have been submitted in response to Tender Reference: 704402452, the Authority will use the negotiated procedure without prior publication of a contract notice to negotiate with LiveLink Technology Limited on the basis that the initial conditions of contract are not substantially altered.
