Key Criteria: Section 4: Integration, Collaboration & Service Sustainability – 15.00%

Key Criteria: Section 5 Improving Access, Reducing Health Inequalities and Facilitating Choice - 6.00%

Key Criteria: Section 6: Social Value – 10.00%

The weightings for the 6 key criteria were determined by the procurement panel to give appropriate relative importance to each of the sections equally in line with the commissioning expectations for the service. The key criteria were all deemed to be of equal importance and were used to assess the providers performance accordingly.
