Portsmouth City Council intends to award a contract to an existing provider for the provision of an existing service, the Towards Better Health (TBH) partnership.

The aim of the service is to improve support and outcomes for people experiencing rough sleeping who have drug and alcohol dependence needs. It is intended that the initial contract term will be for 12 months, from 1st April 2025 to 31st March 2026 with an annual contract value of £99,993.48

This is a Provider Selection Regime (PSR) confirmation of contract award notice. This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Procurement Act 2023 do not apply to this award. This contract has now been formally awarded using direct award process C on 28th March 2025.

The initial contract value is £99,993.48. It is intended that the contract term will be for 12 months, from 1st April 2025 to 31st March 2026. Portsmouth City Council reserves the right to extend this contract term on a yearly basis, subject to performance and future grant funding.
