comfortable, whilst maintaining their individual dignity, privacy, freedom of choice and

treating them with respect. Providers are asked to assure Service User wellbeing through the

delivery of Service User Focused Outcomes, which have been developed in line with Care Act

guidance.

We can accept completed Provider's Tenders at any point in time over the whole term of the Framework. The framework will be 'open', which means that new providers can

The Framework Agreement includes requirements around delivery of Social Value and payment of the Real Living Wage to staff engaged in the delivery of Services. The Council shall review the contract term around the Real Living Wage annually.

The Framework includes the provision for NHS North East and North Cumbria Integrated Care Board ("the ICB") to purchase Residential & Nursing Care Services, subject to the ICB

signing a Framework Access Agreement. The Cumberland Council potential spend on

Residential & Nursing Care Services over the full 8-year term is estimated to be up to a max

£600m.

The initial period of the contract is 4 years. There are FOUR optional extensions of up to 12

months each. The use of these extensions are at the absolute discretion of the Council.

The contract end date stated on this notice is where all four extension periods are used. If no

extension periods are used, the contract will end in 2029. .
