If a Provider fails to be admitted onto the Framework or a home fails to be added to the framework, the provider may reapply for re-consideration during any of designated Framework reopening term(s) to demonstrate that the framework requirements can be met. The tender evaluation shall be based upon a two-stage process i.e. at a provider and home level, consisting of mandatory requirements and/or minimum standards (pass/failure criteria) for both stages, as outlined in Section 5 Evaluation and Award Process in Part 1 - Information Pack of the tender documents. Only bidders passing all the mandatory requirements in Stage 1 (provider level) will be considered for Stage 2 (homes level) of the procurement process. Applications to add a Children's Residential Home(s) to the framework will not be assessed if bidders have not passed Stage 1 mandatory requirements. Bidders who pass all the mandatory requirements in Stage 1 will be taken forward to Stage 2 and each of its home applications will be assessed individually against the mandatory Stage 2 criteria. Individual homes that have passed all of the mandatory criteria in stage 2 will be added as Children's Residential Homes to the framework.
