The new service will build upon the interim arrangements that have been put in place which have ensured a gap in provision has been filled so that families and affected others can access vital support that improves their health and wellbeing outcomes.

The Provider is expected to be responsible for providing this service, liaising closely with the Council.

The service will be available to the whole population of Lincolnshire.
