Supported Accommodation - High quality accommodation and support in community-based settings, that enables people with a mental health need to gain and retain the skills

necessary to live as independently as possible by promoting these skills and promoting social inclusion.

Floating Support - Visiting floating support that is delivered on a citywide basis and enables people to gain and retain the skills necessary to continue to live as independently as possible by promoting those skills and social inclusion.
