The most pressing need for the NI Public Sector Shared Network Project is to address the expiry of the existing NICS Contract (Network NI) which is due to finish in September 2019. It is anticipated that the NI PSSN Contract will be for a maximum contract period of 9 years. This is likely to be on the basis of an initial contract period of five (5) years from 'go-live', plus two optional extension periods consisting of two (2) x two (2) years.
