Description

Tees Valley Combined Authority (the 'Contacting Authority'), part of the Tees Valley Combined Authority Group, are looking to procure

a supplier to install, maintain and operate a private 5G network located at Teesside International Airport.

- £400,000 excluding VAT
- £480,000 including VAT

Description of possible extension:

Eight optional one-year extensions. To be utilised if the 5G network is still required following the initial two year contract. The optional extensions will be reviewed and potentially taken on an annual basis.

There may be a requirement in the future to expand the network to further sites, which may necessitate increases to the contract value
