- Steam clean and stove all existing stator and rotor windings
- Check all bearing housings/seating's for size and tolerances

- Check balance rotor
- Carry out all relevant static electrical tests
- Reassemble machine fitting three new bearings
- Paint machine
- Delivery of alternator back to site for installation and site commissioning
