Herts FullStop as the Contracting Authority, acting on behalf of the Participant (Hampshire County Council) is leading on the procurement process to establish a Framework Agreement for the supply & delivery of Steel Lockers and is seeking a suitably qualified Contractor to supply the Goods under any Agreement resulting from this tendering exercise. The requirement is for the direct delivery of Goods to various locations throughout each Participating Authority and users of the Framework. Please note: - This Tender is single contractor award; tenders will be required to bid for all goods in order to be considered.- Tenderers must have both ISO9001 & ISO14001 in order to be considered for this tender as stated on bid form 12 & 13 of the response document. The estimated total value of the Framework Agreement is stated in II.1.5) of this notice and is for the four year term together with the Call-Off Contracts. For the avoidance of doubt, the estimated annual value of the Contract will be approximately £150,000.00 per annum. The Framework Agreement will be awarded for the term of four years, without an extension period. Please note that the contract requirements will be subject to available financial resources, supplier performance and flexibility to meet changing demands. There will be no form of exclusivity or volume that is guaranteed under the resultant Framework Agreement and the Council and other participating authorities will be entitled to enter into other contracts and arrangements with other suppliers for the provision of any, or all, of the requirements which are the same as, or similar to those specified under the established Framework Agreement. Organisations should be aware that due to the nature of the Services provided, Framework Agreement formed as a result of this procurement process shall be executed as a deed. Organisations should seek independent legal advice on the implications of this prior to submitting their bid, where appropriate.

The Public Contracts Regulations 2015 ('Regulations') provide for aggrieved parties who have been harmed or at risk of harm by a breach of the rules to take action in the High Court (England, Wales and Northern Ireland). Where a Framework Agreement has not been entered into the court may order the setting aside of the award decision or order the contracting authority to amend any document and may award damages.
