- Life skills & independent living;
- Employability & work readiness; and
- Volunteering & social action (which enables social mixing)

The residential experiences overview:

- 4 nights and 5 days away as standard
- Cohort group sizes that promote mixing and engagement
- Socially mixed cohorts
- Residential experiences can be delivered at any point in the year
- Residential Experiences should have a primary focus on one of the three NCST objectives
- A variety of inclusive venues are to be used (e.g. outdoor centres, student flats, hostels, boarding schools)
- Deliver Youth led project-based learning experiences
- Collaborate with relevant third-party partners (e.g. employers, social action partners)
- Provide action and reflection development models
- Make residential experiences visible on NCST electronic systems platform

Young people can access only one residential experience. Young People may have a choice of residential experiences including:

The Supplier (including a consortium formed Supplier) operates the accommodation sites used for delivery of a minimum of 25% and a maximum of 75% of all Residential Experiences delivered.
