VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

DPS extended to 02/06/2028 to accommodate provisions within Procurement Act 2023.

Value of DPS increased from £75m to £90M.

VII.2.2) Reasons for modification

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

The DPS has provisions to extend to 02/06/2029.

The DPS is being extended to 02/06/2028 to meet with Procurement Act legislation which states all DPS must end in February 2029.

The Council is not extending the DPS to it's fullest extent as a new procurement for a replacement solution is required to allow for changes to specification and terms and conditions.

The extension keeps the DPS within it's period of validity so is compliant with PCR2015.
