These are personal injury claims in relation to industrial diseases or injuries such as Chronic obstructive pulmonary disease, mesothelioma, asbestosis, pleural plaques (in Scotland), pleural thickening, lung cancer, skin cancers, vibration white finger and deafness. In addition the service provider will be required to manage the Coal Industry Pneumoconiosis Compensation Scheme (CIPCS). BEIS are looking at all potential procurement routes including competition under the new CCS RM6179: Legal Services Panel framework agreement.
