1. Wider Family Learning (WFL) provision is designed to support different generations of family members to learn separately and / or together. It has the aims of:

- developing the skills and knowledge of both the mother/father/carers and child participants
- enabling mothers/fathers/carers to be more active in the support of their children's learning and development and to understand the impact of that support

2. Family English, Maths and Language (FEML) is provision designed for mothers and fathers (or other carers of children) with English and Maths needs or is for families where English is not the primary language. Programmes should aim to:

- improve the English, Maths and Language skills of mothers and fathers (or carers) and their ability to help their children
- improve children's acquisition of English, Maths and Language skills

3. Personal and Community Development Learning (PCDL) is learning for personal and community development, cultural enrichment, to acquire a new skill or to pursue an interest. In most cases there would be no formal qualification outcome attached to such

learning.
