Through the organisation's duties as landlord, various isolated and vulnerable tenants have been identified as in need of a tailored support to understand and manage their hoarding tendencies, improve their quality of life and live safely in their tenancy.

NIHE seeks to procure contracts with appropriate supportive approaches, so that sustainable positive outcomes and harm reduction can be achieved.
