The Council is seeking to make an initial purchase of approximately 35 containers to meet this requirement. The final number will be dependent on the prices submitted as part of the process.

Following the initial purchase, the Council may wish to use this contract to purchase further containers (up to a maximum of 20) over the 12 month term of this contract.
