Scope

Description

The Prime Minister has announced an ambition that, as part of their education, every student in the country should have the opportunity to hear a recorded Holocaust survivor testimony. The Department for Education has allocated up to £2m for financial year 2025-26 to support this work.

- signposting to current high-quality provision; and

- supporting schools with the hardware needed to access such software programmes by buying VR headsets that they can use.

The Department will be seeking organisations with the capacity and experience to implement and start delivering quickly on this programme.
