#### II.2.4) Description of the procurement

- 1. The primary purpose of this prior information notice (PIN) is to alert potential suppliers to an opportunity in relation to bus services across Windsor and Maidenhead. At present, RBWM envisage 6 packages of services with the lotting structure to be determined. It is likely the opportunity will be formally published in the coming weeks.
- 2. This contract operates as follows: RBWM provide fixed payments to support the

operation of the bus services. Any income yielded from the services, however, remains with the supplier. The contract's status as a concession contract is yet to be assessed.

- 3. This opportunity is likely to be for an initial term of 5 years with extension options available. The anticipated support for all 6 packages is likely to be in the region of £1.2m £1.3m per annum.
- 4. The services are a core requirement for RBWM and it is expected that commencement of the new contracts shall be no later than 1 April 2025. However, this is yet to be finalised. RBWM is currently considering its procurement route and is currently considering the open procedure or a competitive negotiation procedure; nevertheless, we are not making conclusive representations at this juncture.
