It is considered that this contract can be awarded using the negotiated procedure without prior publication of a contract notice pursuant to regulation 32(2)(b)(i) of the Public Contracts Regulations 2015 (Article 32(2)(b)(i) of Directive 2014/24/EU) for the aim of the procurement is the creation or acquisition of a unique work of art or artistic performance.
