This Prior Information Notice has been published by the Procurement and logistics organisation (PaLS) Business services organisation (BSO) on behalf of the Western Health and Social Care Trust (WHSCT). This PIN is intended to inform the market that the WHSCT are proposing to award contracts for the Provision of Domiciliary Care Services in the Western Health and Social Care Trust Area and therefore wish to carry out pre tender market engagement with interested Providers. Due to the ongoing Covid-19 pandemic we are unable to meet with the market in person. Therefore in the interests of transparency and equal treatment this approach conducted in writing is being used for the purpose of pre tender market engagement in advance of any tender process. This Tender is governed by the Public Contract Regulations 2015. The service being tendered is classified as a 'Social and other specific service' therefore the Light Touch Regime (regulations 74-77) applies. This pre tender market engagement will take the form of a paper and questionnaire for providers to respond to. The purpose of this exercise is to engage with and receive feedback from the market by outlining the Trust's proposals for the delivery of domiciliary care services in the Trust area including the proposed model and key elements of the service, and its procurement plans and requirements.
