The contract term will be for 12 months, with the option to extend for a further 12 months. Three initial issues will be developed and made available by September 2026, December 2026 and March 2027.

To ensure that resources are of the highest quality, accurate, relevant, accessible, and engaging, we strongly encourage bidders to actively explore opportunities for collaboration with a diverse range of stakeholders.
