Some sites will only require updates to key stops on the routes at the sites as opposed to re-doing the whole recording for the site.

The contract will provide some stability for the recovery of our sites owing to the impact of the COVID global pandemic and will also allow HES time to review the future requirements before going back to the marketplace for a new audio guide content and maintenance contract.
