A fee of £0.95 will be paid for each item dispensed as part of the service.

The Pharmacy will be reimbursed for the medication supplied under the 'CATC' service according to the current dm+d price.

Where patients are not exempt from prescription charges and have paid the NHS Levy to the Pharmacy, such sums will be deducted from the relevant month's remuneration.
