#### **VII.2) Information about modifications**

##### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

Change 001 resulted in no price increase.

Change 002 amended Phase 1 scope to account for increased unforeseen complexity = +£0.29m

Change 002 was an earlier modification reliant on 72(1)(e) which extended for 2 months.

Change 003 amended scope to remove uncertainty and de-risk subsequent phases =

+£0.39m

Change 003 is the modification reliant on 72(1)(b) which extends Phase 1 for a further 2 months.

Change 003 has an option to extend for a further 1 month. Any increase in price for this optional 1 month would not exceed 50% of the value of the original contract.

The award provides an option for 36 months for Phase 2.

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

Need for additional works, services or supplies by the original contractor/concessionaire.

This contract is being modified in accordance with Regulation 72(1)(b) of the Public Contracts Regulations 2015, and the change is made for additional services or supplies by the original contractor that have become necessary and were not included in the initial procurement, where a change of contractor -

- (i) cannot be made for economic or technical reasons such as requirements of interchangeability or interoperability with existing equipment, services or installations procured under the initial procurement, and
- (ii) would cause significant inconvenience or substantial duplication of costs for the contracting authority

provided that any increase in price does not exceed 50% of the value of the original contract.
